1. The work for laying of internet cable can be started after issuance of work order.
2. The work for laying of cable will be done with information / presence of representative of OPF from Site Office.
3. The company will be responsible for back filling of excavated material and leveling the area.
4. The company will be responsible for rectification of damage of existing infrastructure / services of the scheme occurred during execution of work.
5. OPF reserve the right to award work / sign the frame contract to one or more than one bidders / company.
6. OPF reserves the right to reject any or all bids due to a solid reason.
7. The firms / companies registered with concerned authority i.e. PTA, PEMRA, etc. will allowed submitting their bid. The request of un-registered firms / companies will not be entertained / considered.
8. The successful firms / companies are bound to submit at least a sum of Rs. 100,000/- (on lac) as security amount through Pay order / Demand Draft in favor of “OPF”.
